ABOUT THE COURSE

Safety Officers are responsible for planning, implementing and overseeing company's employee safety at work. Their main duty is to ensure that the company is in compliance and adheres to Occupational Health and Safety (OHS) guidelines.

While the role of a safety officer will differ based on a company's industry, organizational size and structure, and unique safety needs, there are general role requirements that apply to most safety officers. Along with these core areas, a safety officer is also required to communicate hazards and risks to prevent injury, creation and implementation of mitigation tools and programs, and conducts investigations to determine the true causes leading up to any incidents or near incidents. A safety officer's role in reality goes beyond regulatory compliance. Many organizations' own policies go far beyond what is required by law. Therefore, it is essential that all safety professionals help develop and sustain workplace cultures that are driven by values not only regulatory consequences.

OBJECTIVE

This program intends to benefit the safety officers working in factories, docks and construction sites in efficient management of safety and health at workplace through the application of various safety and health management techniques.
