## **ABOUT THE PROGRAM**

Industrial workers in their day-to-day work are exposed to various kinds of health hazards at workplace. Occupational diseases resulted due to workers exposure to chemical hazards (viz., toxic gases, fumes, vapours, dusts, fibers etc) and physical hazards (Noise, Heat etc.) Rapid industrialization and recent advances in technology many times brings out unknown hazards, due unawareness these lead to exposure and occupational illnesses among employees at industrial workplaces. To overcome these hazards & there related issues, implementation of the best OSH practices with

understanding of Industrial Hygiene, Health & Safety at industrial workplace is essential. In Industrial hygiene, Anticipation and recognition of the workplace hazard form a basis for further evaluating such hazards through WEM and later their control. Several provisions in the Factories Act, 1948 mandate compliance towards providing of safe and healthful workplace at factories in India.
