To overcome these hazards & there related issues, Selection, Maintenance and use of PPEs as last level in hierarchy of control the hazards.

In Industrial hygiene, Anticipation and recognition of the workplace hazard form a basis for further evaluating such hazards through WEM and later their control. Several provisions in the Factories Act, 1948 mandate compliance are made about the Use, Selection and Maintenance of PPEs in industries.
