Studies on workers' participation in India have revealed that the goal of industrial democracy depends on the extent to which, are Safety Committee members co-operative, committed and have mutual trust. It calls for members to possess sound knowledge and skills for the effective functioning of the Committee. Along with that, members are required to develop competency to identify and solve the problems related to Safety, Health and Environment.
