The safety provisions related to equipment and machinery safety involved in excavation works during construction activity. It is essential that all safety professionals help develop and sustain workplace cultures that are driven by safety culture — not only regulatory consequences.

This program intends to benefit the safety officers / safety professionals / supervisors working at construction sites / construction related works inside factory premises in managing risks at ALARP levels.
