In this regard, Occupational Health and Safety Audit is carried out to evaluate the effectiveness of the company's safety effort and comply the recommendations which lead to reduction in accidents and minimization the loss potential. IS 14489:2018, code of practice on Occupational Safety and Health Audit provides guidelines for establishing, planning, conducting and documenting of audits on occupational safety and health systems at workplace.

#### **Programme Objective**

Safety audit is a systematic review to analyze the risks and hazards in the workplace and evaluate the effectiveness and reliability of the safety procedures set up in the organization. This training programme is designed to equip participants, with the knowledge and skills in order to ensure that the facility is safe to operate.
