About the Course/Training Programme:

Unexpected releases of toxic, reactive, or flammable liquids and gases in processes involving highly hazardous chemicals have been reported for many years. Incidents continue to occur in various industries that use highly hazardous chemicals which may be toxic, reactive, flammable, or explosive, or may exhibit a combination of these properties. Regardless of the industry that uses these highly hazardous chemicals, there is a potential for an accidental release any time they are not properly controlled. This, in turn, creates the possibility of disaster. The PSM requirements were created in response to a series of catastrophic incidents related to highly hazardous chemicals (HHC). These requirements have been updated and expanded several times in the last two decades, and all HHC-related companies should keep a lookout as they operate and expand. A sound Process Safety Management

(PSM) program is essential to any business that has highly hazardous substances onsite.

Objectives:

PSM is essential for managing complex operations as well as simple operations involving hazardous materials. The elements of PSM focus on Technology, Facilities and Personnel. This training program is designed to ensure the facility is safe to operate, equipment is maintained properly, and there are proper operating procedures in place.
