The Factories Act, 1948 (as amended in 1987) and enactment of the Manufacture, Storage and Import of Hazardous Chemicals (MSIHC) Rules, 1989 have placed additional responsibilities on the managements for proper management of hazardous substances. Implementation of statutory provisions on the part of the Management to ensure proper use, handling, storage, import and disposal of hazardous substances/chemicals and to arrange for necessary supervision during hazardous processes is very important. It is, therefore, imperative that all concerned particularly those in the hazardous process industries/MAH industries should be fully aware of the hazards associated with the use of hazardous substances and control thereto.
