In industrial establishments, construction sector and in Docs work, most of workers vulnerable to expose to heat stress condition due to their day-to-day involvement in work apart of simultaneous exposure to other health hazards.

Prolong exposure to heat stress condition create stresses, discomfort, impact productivity, safety and well-being of the workers. Awareness about Heat stress at workplace, Heat exposure assessment and their control measures are essential to mitigate risk associated with it. To overcome workplace heat stress issue, implementation of best OSH practices with common understanding of Industrial Hygiene, Health & Safety at industrial workplace essential. Several provisions toward providing safe and healthful working conditions and compliance are mandated in industrial workplace under the The Factories Act-1948, BOCW Act-1996 for construction sectors in India.
