ABOUT THE COURSE

Electrical safety is a general practice of handling and maintaining electrically powered equipment to prevent incidents. Adequate training is required to properly identify and control hazards to keep the environment safe for those around.

Electricity can electrocute or severely injure people and cause damage to property. However, we can take simple precautions when working with or near electricity and electrical equipment to significantly reduce the risk of injury to you, your workers and others around you.

Better safety equates to better health. Healthier employees do tasks more efficiently, and they are happier in general. There are very few accidents in a safe working environment. This results in less downtime for safety investigations and reduces costs for worker's compensation.

OBJECTIVE:

Electrical safety is important because hazards such as arc flash and electrical shock can result in death if you are exposed to them. The likelihood of this occurring is relatively low. However, the control measures that prevent these hazards require careful management, attention to detail and technical competence, and training and retraining.
