Hazardous processes are work processes that carry an inherent health and safety risk to the worker. Under Chapter IVA of Factories Act (Section 41A- 41H) deals about the Hazardous processes. An effective process safety management system can not only help to avoid incidents; it is the key to ensure efficient, reliable and robust operations. Process safety management addresses the safety measures required to prevent accidental release of hazardous material from its containment, like a vessel, tank, piping or pipeline. Therefore, PSM refers to the integrated management of interrelated activities required to manage process safety risks.

Process Safety Management (PSM), enables you to identify the hazards and assess the associated risks specific to your asset/ facilities and prioritize them. It also helps to predict, assess, and quantify human errors in relation to safety critical tasks. This training program is designed to evaluate the facility is safe to operate, equipment is maintained properly and there are proper operating procedures in place.
