This training programme has been designed to enrich knowledge and expertise of the participants in dealing with the prevention of electrical-related injuries, implementing proactive controls across the spectrum of expected hazards, educating the workers about electrical hazards and demonstrating the compliance to established standards.

The aim of the "Electrical Hazards & Safety at Workplace" program is to equip participants with the knowledge and skills necessary to identify, assess, and mitigate electrical hazards in the workplace. Through comprehensive training the program aims to promote a culture of safety, reduce the risk of electrical

accidents, and ensure the well-being of employees and the integrity of the work environment.

The objective of this programme is intended for safety professionals and engineers in the areas of Electrical safety to upgrade safety performance of the equipment/ plants and covers the methods of identifying, assessing and reducing hazards including evaluation and selection of methods.
