#### **About the Institute**

### **About the Programme**

Major accidents may cause emergency and it may lead to disaster, which may cause heavy damage to plant, injury to persons and create adverse effects on the environment. Emergency situation may arise all of a sudden and create havoc and cause extensive damage to the property, environment and harm to human beings. Therefore, such situations and risks should be thought, visualized and assessed in advance and it should be planned before hand to tackle them immediately and control them within the shortest possible time.

## **Programme Objective**

Emergency planning demonstrates the organizational commitment towards safety of workforce and enhances organizational commitment. Further, Section 41B (4) of the Factories Act, 1948 states that every occupier of a factory shall draw up an on-site Emergency Plan and detailed disaster control measures for his factory, and make known to the workers employed therein. Therefore, it is perilous to prevent it through technical as well as administrative measures in industries and ports.
