DGFASLI is an attached Office of the Ministry of Labour & Employment, Government of India and serves as a technical arm to assist the Ministry in formulating National policies on occupational safety and health in factories and docks.

The Factory Advice Service Division under DGFASLI coordinates the administration of the Factories Act in the States and advises the Central and State Governments on related matters including interpretation, formulating and recommending amendments of the provisions of the Factories Act and framing of Model Rules. The Division also advises on documents on safety and health from the International Labour Organisation and other international agencies.

ABOUT THE COURSE

Factory Inspectors play a crucial role within the Labour Administration System, responsible for upholding the requirements in the Factories Act of 1948 and ensuring adherence to safety and health standards across the country. They are tasked with enforcing the provisions set forth in the Factories Act of 1948 and the State factories Rules framed there under.

"This 5-day Refresher Course for Inspectors of Factories" has been designed to enhance the knowledge and skills of experienced factory inspectors, particularly focusing on the Occupational Safety and Health (OSH) Framework and

placing a stronger emphasis on the requirements outlined in the Factories Act of 1948 and the State Rules framed thereunder. This course addresses the practical aspects relevant to experienced and senior factory inspectors, aiming to equip them with updated expertise in their field.

OBJECTIVE

- ❖ To refresh, equip and enable the Inspectors with the provisions of the Factories Act, 1948, Model Rules framed there under, and ancillary rules and regulations pertaining to OSH in the factories.
