Guidelines/Instructions as mentioned in the Information Brochure for taking part in the Open Round Counselling for the Vacant Seats amongst Rank-51 to Rest as per the published merit list.

- Reporting & Open Round Counselling for the 25 Vacant Seats
  - Reporting: If any candidate of Rank-51 to Rest, wants to take admission against the vacant seat, he/she has to appear physically on 24.03.2025, before 5 PM at the Regional Labour Institute, Sarvodaya Nagar, Kanpur – 208005 and submit a physical application for his/her willingness to attend the open round counselling for the vacant seats to "The Director in Charge, Regional Labour Institute, Sarvodaya Nagar, Kanpur – 208005". Candidature for the rest of the candidates will automatically be cancelled, and no request will be entertained, and no correspondence will be made, in this regard in any circumstances.
  - Filling of the vacant seats will be made on 25.03.2025, 11 AM onwards, strictly as per the order of merit, only from the candidates reported and applied on 24.03.2025 till 5 PM to attend the open round counselling for the vacant seats. The physical appearance of the candidate himself/herself with all original documents is essential during the allotment of seats on 24.03.2025 and 25.03.2025 and no authorization to any other person will be entertained in this regard in any circumstances
- Those who are currently working (either permanent or contractual), if selected, No Objection Certificate (NOC)/Permission Letter/Sponsorship Letter/ Relieving Letter/Accepted Resignation letter to be submitted at the time of document verification and admission.
- All the Original Certificates, Testimonials, etc. regarding Educational Qualification, Experience, etc., must be produced in original at the time of document verification & admission to the course without fail and non-producing of these documents may disqualify the candidate from seeking admission to this training programme.
- The candidate shall be disqualified from admission to the course or from continuing in the course if any information provided is found to be incorrect/false/fabricated/tampered/misleading/mismatch at any point of time.
