- Open Round Counselling: Filling of the vacant seat(s) (if any) will be made on 25.05.2026, from 2 PM to 5 PM, strictly as per the order of merit from the reported candidates only. The physical appearance of the candidate himself/herself with all original documents is essential during the allotment of seats on 25.05.2026 and no authorization to any other person will be entertained in this regard in any circumstances. However, if the number of vacant seats are more than the number of eligible waitlisted candidates then, the waiting listed candidates may take admission till 26-05-2026 till **5 PM**.

- Those who are currently working Sponsorship Certificate/No Objection Certificate (NOC)/Permission Letter/Relieving Letter/Accepted Resignation letter to be submitted the time of admission.
- Submission of incomplete, false, fabricated, tampered, misleading, or mismatched information may lead to rejection of the application and cancellation of the candidature at any stage.
- Applicants shall bring four (04) passport size photographs, all original documents attached with the application form and relieving order from present employer (if currently working).
- Any discrepancy/short fall/mismatch if found during documents verification, the candidature will be cancelled. No request in this regard will be entertained.
- The candidates will also be required to pay the Program Fees of Rs 30,000/- (Rs Thirty Thousand only) through online mode - Bharat Kosh only, after their certificates have been verified and they are admitted to the course. The candidates shall come prepared with online payment facility like internet banking/ debit card/ Credit Card/ UPI. Printout of the receipt generated on Bhart Kosh on successful payment has to be submitted to the Institute on the day of admission.
- An additional Rs. 5,000/- towards Examination and Registration fees is to be paid by all candidates at the time of registration for final examination.
