This notice is applicable only to the waitlisted candidates belonging to the jurisdictional States/UTs of Regional Labour Institute, Faridabad.

It is hereby informed that, after completion of the admission process for the merit-listed candidates of the Post Diploma in Industrial Safety (PDIS) Course, 2026-27 at the Regional Labour Institute, Faridabad, certain seats have remained vacant. The vacant seats available for admission from among the eligible waitlisted candidates under the jurisdiction of RLI, Faridabad are as follows:

The admission against the above vacant seats shall be carried out strictly from among the eligible waitlisted candidates against the Open Category, as per the prescribed admission procedure mentioned in the Prospectus and the admission notice of RLI, Faridabad.

The waitlisted candidates belonging to the jurisdictional States/UTs of RLI, Faridabad, who report at the Regional Labour Institute, Faridabad on 28.09.2026 from 9:30 to 17:00 Hrs, will be considered for admission, subject to the availability of vacant seats and strictly in the order of merit. After 17:00 hrs if any seat remains vacant will be offered on first come first serve basis to waitlisted candidates (out of jurisdiction candidates will also be considered, if seat remain vacant). Candidates reporting after 17:30 hrs will not be considered for admission under any circumstances.

The candidates concerned are required to report to the Regional Labour Institute, Faridabad for original document verification and admission on the date and time mentioned above. Candidates shall be considered for admission subject to fulfilment of all prescribed eligibility conditions and successful verification of the required original documents.

All other terms and conditions, eligibility requirements, original document verification requirements and admission procedures shall remain the same as those mentioned in the Admission Notice for the PDIS Course 2026-27 issued by RLI, Faridabad, dated 22.09.2026.
