#### THE TRAINING PERSPECTIVE:

- The significance of the training program on industrial health for doctors lies in its capacity to enhance their expertise and knowledge, equipping them with the necessary skills to address and manage health challenges specific to industrial settings. This three Months Duration Training Programme in Industrial Health will enable Indian Registered Medical Practitioners of Modern Medicine to become medical officers who are considered occupational health physicians in different industrial establishments. Upon successful completion of the training program and passing the final examination, participants will be granted the certificate.
- It is a three months duration, full-time, regular, offline training programme consisting of lecture series, laboratory work, practical works, demonstration & tutorial, educational / industry visits, speciality clinical exposure and mandatory project work. The practical, tutorial, and demonstration activities are integral components of the said course curriculum with the involvement of multiple disciplines including Industrial Medicine, Industrial Hygiene, Safety, Staff Training and Productivity, Human Physiology, Industrial Psychology, Ergonomics etc.

## **DURATION OF THE TRAINING PROGRAMME:**

The programme will be conducted in offline mode from 28.05.2024 TO 28.08.2024 at RLI, Faridabad.

#### NOMENCLATURE OF THE TRAINING PROGRAMME:

• Three Month Duration Training Programme in Industrial Health.

#### **ESSENTIAL ELIGIBILITY CRITERIA FOR ADMISSION:**

- 1. Candidates in possession of recognised medical qualification as per the provisions of the National Medical Commission (NMC) Act, 2019 and the repealed Indian Medical Council (MCI) Act, 1956.
- 2. Have completed one year of internship period.
- 3. Possessing permanent registration certificate issued by the NMC/ the erstwhile Medical Council of India or State Medical Council to practice medicine in India.
- 4. Minimum Two years working experience (as on the date of publication of the information brochure cum application form) in any establishment or self-practice after completion of the compulsory internship period. The period spent on higher studies in the field of modern medicine i.e. recognised postgraduate medical degree/diploma (MD/MS/DNB/Diploma) or an equivalent recognised medical qualification as per provisions of the NMC Act 2019 and the repealed Indian Medical Council Act 1956 shall be considered as working experience.

#### **SELECTION CRITERIA FOR ADMISSION:**

Maximum Intake capacity for this training programme at Regional Labour Institute, Faridabad is 50.

If the number of applicants who have fulfilled the essential eligibility criteria for admission as mentioned above, are more than the maximum approved intake capacity of this institute, then only the selection criteria (Objective Criteria based Merit List) as mentioned below shall be followed,

After completion of the compulsory internship period,

- 1. Two (2) mark will be given for each completed year of working experience in Factory, Mines, Dock Works, Construction Work, and Plantation Work.
- 2. One (1) mark will be given for each completed year of working experience other than Factory, Mines, Dock Works, Construction Work and Plantation Work or self-practice or period spent on higher studies in the field of modern medicine i.e. recognised postgraduate medical degree/diploma (MD/MS/DNB/Diploma) or an equivalent recognised medical qualification as per provisions of the NMC Act 2019 and the repealed Indian Medical Council Act 1956.
- 3. TIE PRINCIPLE –Wherever two or more candidates have secured equal aggregate marks, these tie(s) is/are resolved in accordance with the principles as mentioned below,
  - Priority-1: Age-Senior will be in the upper order of merit.
  - Priority-2: Date/Year of Completion of the Internship-Earlier the date/year of completion of internship will be in the upper order of merit.

#### **VENUE OF THE TRAINING PROGRAMME:**

#### **APPLICATION PROCEDURE:**

- Intrested candidates can apply by sending the duly filled application form in prescribed proforma along with selfattested copies of necessary attachments through **speed post only** to "THE HEAD OF OFFICE, REGIONAL LABOUR INSTITUTE, SECTOR-47, FARIDABAD, HARYANA-121010".
- On the outer envelope, it shall be clearly written as: "APPLICATION FOR THREE MONTHS TRAINING PROGRAMME IN INDUSTRIAL HEALTH AT RLI FARIDABAD"
- Last Date for receipt of the Application form by speed post to the Regional Labour Institute, Faridabad: **10.05.2024**. Application forms sent by e-mail or submitted by hand will not be considered/accepted.
- Mere application for the training programme does not confirm the allotment of the seat.
- List of the provisionally eligible candidates will be notified/published on or before: 14.05.2024 and List of Non-Eligible Candidates with reason will also be notified/published on or before: 14.05.2024.
- Objective Criteria based Merit List (Rank) of the provisionally eligible candidates and non eligible candidates with reasons will be notified/published on or before:15-05-2024.
- Physical Verification of the original documents followed by admission and fees deposition for the first 50 candidates (Rank:1 to 50) as per merit list will be conducted on 20.05.2024 and 21.05.2024 till 4 PM. If a candidate up to Rank-50, does not take the admission and does not deposit the fees by 21.05.2024 till 4 PM, his/her candidature will automatically be cancelled and no corespondance will be entertained in this regard in any circumstances. During admission process, the physical appearance of the candidate with all original documents is essential and no authorization to any other person will be entertained in this regard in any circumstances.
- Publication of the Number of Vacant Seats will be published by 23.05.2024 on DGFASLI website.

### Reporting & Counselling for the Vacant Seats:

1. If any candidate of Rank-51 to Rest, wants to take admission against the vacant seat, he/she has to appear physically only on 27.05.2024, till 11 AM at the Regional Labour Institute, Sector-47, Faridabad, Haryana-121010 and has to submit a physical application for his/her willingness to attend the counselling for the vacant seats to "Head of Office, Regional Labour Institute, Sector-47, Faridabad (Haryana)-121010". Candidature for the rest of the candidates will automatically be treated as cancelled and no request will be entertained in this regard in any circumstances.

- 2. **Filling of the vacant seats will be made on 27.05.2024, 11.30 AM onwards**, strictly as per the order of merit, only from the candidates reported and applied on 27.05.2024 till 11 AM to attend the admission procedure for the vacant seats. The physical appearance of the candidate himself/herself with all original documents is essential during the allotment of seats on 27.05.2024 and no authorization to any other person will be entertained in this regard in any circumstances.
- 3. Mere reporting and presence in the admission procedure do not confirm the allotment of seats.
- No TA/DA/etc will be provided to attend the document verification/admission/reporting/counselling or for any other purpose.
- Information related to admission/selection or any other matter for this training programme will be notified/updated on the Notice Board of Regional Labour Institute, Faridabad and DGFASLI website (<a href="https://dgfasli.gov.in/">https://dgfasli.gov.in/</a>) from time to time. No personal communication will be made to individual candidates.
- The admission process will end on 27.05.2024 by 1700 hrs.
- Commencement of the Training programme will be on 28.05.2024.
- Detailed training programme schedule will be intimated/notified in due course of action to the selected candidates.

#### STIPEND/INCENTIVE/BOND POSTING:

There will be no provision for stipend/incentive/bond posting to the selected participants of the said course.

#### IMPORTANT INFORMATION:

- Only after verification of all documents with original copies and submission of required papers and after confirmation
  of the provisionally selected candidates by this institute will be allowed to deposit fees as per the details given below;
  - 1. Fees for the Training Programme: On the day of admission to the course, the provisionally selected candidates will have to deposit institute fees by online payment of Rs. 25,000/-((Rupees Twenty Five thousand only) (Non-refundable)) through Bharatkosh portal (Go to https://bharatkosh.gov.in ). Fees once submitted will not be refunded.
  - 2. Caution Money: An amount of Rs. 2500/-(Rupees Two thousand five hundred only) has to be deposited to this institute. This amount is refundable subject to recoveries, if any, at the end of the course. The mode of payment of the caution money deposit will be communicated to the selected candidates by the Industrial Medicine Divisoin of the Regional Labour Institute, Faridabad, Haryana.
- This provisional admission will be granted based on the information/documents furnished by the Candidates as
  per their application form and during the admission process. In case of any
  credentials/information/document/certificate etc. being detected or identified or being noticed at any point as
  false/fabricated/tampered/misleading, his/her candidature and certificate will be cancelled and the fees paid
  will not be refunded.
- All the Students are required to bring TWO passport-size photographs and one set of self-attested photocopies of all documents/certificates/testimonials including educational & experience certificates along with originals.
- During the training programme a minimum of 75% attendance is mandatory to appear for final examinations. Attendance will be counted from the first day of commencement of the course. Those who do not fulfil the minimum required attendance criteria would not be allowed to appear in final examinations.
- All students are required to adhere to the uniform dress code for doctors i.e. White Coat/Apron.
- The expenses towards Food/Stay/Industry Visits/Project Work/Term Work/Examination fees/Lab Reports Books, /Stationeries/copies of study materials/handouts/lectures/ notes and other assignments, etc as part of the curriculum have to be borne by the candidate himself/herself/sponsoring organization.
- The classes will be held from 09.30 am to 05.30 pm on all working days (Monday to Friday).
- During the tenure of the course, students are required to keep track of the different components of the training programme. The Institute will not be responsible if any deadline is missed by the student.

- Any kind of indiscipline/uncivilized behaviour and unparliamentary language in the Institute, hostel, and campus shall be dealt with strictly and disciplinary action will be initiated by the competent authority.
- There shall be a total ban on any act of ragging performed directly or indirectly by any student of the institute. No student shall commit, abet, propagate, or participate directly or indirectly in ragging in or outside the institute.
- Every student is required to observe discipline and maintain decorous behaviour both inside and outside the Institute and not to indulge in any activity which will tend to bring down the prestige of the Institute and against the professional ethics of the medical practitioners. The Head of Office, Regional Labour Institute, Faridabad, Haryana will constitute a disciplinary committee to enquire into acts of Indiscipline/misconduct. Appropriate action will be taken and communicated to the appropriate authority or organization based on the findings of the disciplinary committee. If a student indulges in malpractice, he/she shall be liable for punitive action as prescribed by the Institute from time to time.
- For any matter related to this training programme, the Decision of the Competent Authority i.e, Head of Office, Regional Labour Institute, Faridabad as applicable/appropriate will be final.

#### **HOSTEL ACCOMMODATION:**

A limited number of non-family hostel accommodations may be available on twin sharing basis in the Hostel of the institute at a central government-prescribed rate. Arrangements for all food and refreshments are to be made by the participants themselves during the course. The programme is non-residential. Staying in the hostel is optional and not compulsory. Only applying for the said course does not confirm the allotment of the Hostel room. The allotment of the hostel rooms is subject to availability. The decision of the Head of Office, Regional Labour Institute, Faridabad in this regard will be final.
