#### THE TRAINING PERSPECTIVE:

- The significance of the training programme on industrial health for doctors lies in its capacity to enhance their expertise and knowledge, equipping them with the necessary skills to address and manage health challenges specific to industrial settings. The Month Duration Training Programme in Industrial Health will enable Indian Registered Medical Practitioners of Modern Medicine to become medical officers who are considered occupational health physicians in different industrial establishments. Upon successful completion of the training program and passing the final examination, participants will be granted the certificate of Associate Fellow in Industrial Health.
- It is three months duration, full-time, regular, offline training programme consisting of lecture series, laboratory work, practical works, demonstration & tutorial, educational / industry visits, speciality clinical exposure and mandatory project work. The practical, tutorial, and demonstration activities are integral components of the day-to-day course curriculum with the involvement of multiple disciplines including Industrial Medicine, Industrial Hygiene, Safety, Staff Training and Productivity, Human Physiology, Industrial Psychology, Ergonomics etc.

#### **DURATION OF THE TRAINING PROGRAMME:**

• The program will be conducted from **10.02.2025 to 09.05.2025**.

#### NOMENCLATURE OF THE TRAINING PROGRAMME:

• Three Month Duration Training Programme in Industrial Health. Upon successful completion of the training program, participants will be granted the title of "Associate Fellow in Industrial Health", accompanied by a certificate.

#### **ESSENTIAL ELIGIBILITY CRITERIA FOR ADMISSION:**

- 1. Candidates in possession of recognised medical qualification as per the provisions of the National Medical Commission (NMC) Act, 2019 and the repealed Indian Medical Council (MCI) Act 1956, and
- 2. Have completed one year of internship period, and
- 3. Possessing permanent registration certificate issued by the NMC/ the erstwhile Medical Council of India or State Medical Council to practice medicine in India, and
- 4. Minimum Two years working experience (as on the date of publication of the information brochure cum application form) in any establishment or self-practice after completion of the compulsory internship period. The period spent on higher studies in the field of modern medicine i.e. recognised postgraduate medical degree/diploma (MD/MS/DNB/Diploma) or an equivalent recognised medical qualification as per provisions of the NMC Act 2019 and the repealed Indian Medical Council Act 1956 shall be considered as working experience.

#### **SELECTION CRITERIA FOR ADMISSION:**

Maximum Intake capacity for this training programme at Regional Labour Institute Shillong is 50.

If the number of applicants who have fulfilled the essential eligibility criteria for admission as mentioned above, are more than the maximum approved intake capacity of this institute, then only the selection criteria (Objective Criteria based Merit List) as mentioned below shall be followed;

After completion of the compulsory internship period,

- Two (2) mark will be given for each completed year of working experience in Factory, Mines, Dock Works, Construction Work, and Plantation Work
   and
- 2. One (1) mark will be given for each completed year of working experience other than Factory, Mines, Dock Works, Construction Work and Plantation Work or self-practice or period spent on higher studies in the field of modern medicine i.e. recognised postgraduate medical degree/diploma (MD/MS/DNB/Diploma) or an equivalent recognised medical qualification as per provisions of the NMC Act 2019 and the repealed Indian Medical Council Act 1956
- 3. TIE PRINCIPLES Wherever two or more candidates have secured equal aggregate marks, these tie(s) is/are resolved in accordance with the principles as mentioned below,
  - Priority-1: Age-Senior will be in the upper order of merit.
  - then Priority-2: Date/Year of Completion of the Internship-Earlier the date/year of completion of internship will be in the upper order of merit.

#### **APPLICATION PROCEDURE:**

- On the outer envelope, it shall be clearly written as: "APPLICATION FOR THREE MONTHS TRAINING PROGRAMME IN INDUSTRIAL HEALTH AT RLI SHILLONG-2025"
- Last Date for receipt of the Application form by speed post to the Regional Labour Institute, Shillong: 17-01-2025. Application forms sent by e-mail or submitted by hand or received after 17-01-2025 will not be considered/accepted.
- Mere application for the training programme does not confirm the allotment of the seat.
- List of the Provisionally Eligible and Non-Eligible candidates based on initial scrutiny will be notified/published on or before: 23-01-2025.
- Objective Criteria based Merit List (Rank) of the provisionally eligible candidates will be notified/published on or before: 27-01-2025.
- Physical Verification of the original documents followed by admission and fees deposition for the first 50 candidates (Rank:1 to 50) as per Merit List (Rank) will be conducted: 03-02-2025 and 04-02-2025 from 10.00am to 04.00pm. If a candidate up to Rank-50, does not take the admission and does not deposit the fees by 04-02-2025 till 04.00pm, his/her candidature will automatically be cancelled, and no request will be entertained and no correspondence will be made, in this regard in any circumstances. During admission, the physical appearance of the candidate with all original documents is essential and no authorization to any other person will be entertained in this regard in any circumstances.

The physical appearance of the candidate himself/herself with all original documents is essential during the allotment of seats on 10.02.2025, between 10.00 am to 11.00 am and no authorization to any other person will be entertained in this regard in any circumstances.
- Mere reporting and presence on the open round counselling do not confirm the allotment of seats.
- No TA/DA/etc will be provided to attend the document verification/admission/ Reporting/Open Round Counselling or for any other purpose.
- Information related to admission/selection or any other matter for this training programme will be notified/updated on the Notice Board of Regional Labour Institute Shillongand DGFASLI website (<a href="https://dgfasli.gov.in/">https://dgfasli.gov.in/</a>) from time to time. No personal communication will be made to individual candidates.
- The admission process will end on 10.02.2025.

#### STIPEND/INCENTIVE/BOND POSTING:

There will be no provision for stipend/incentive/bond posting to training participants.

#### **IMPORTANT INFORMATION:**

- Only after verification of all documents with original copy and submission of required documents, the provisionally selected candidates will be allowed to deposit fees as per the details given below:
  - Fees for the Training Programme: On the day of admission to the course, the provisionally selected candidates will have to deposit institute fees by online payment of Rs. 25,000/-(Non-refundable) through Bharatkosh portal or through Demand Draft.

- Then proceed to enter relevant details as asked in the portal and continue for online payment through Internet banking/Debit Card/Credit Card/UPI.

The fees can also be paid by a crossed Demand Draft drawn in favour of the "Administrative officer, Regional LabourInstitute, Kolkata" payable at Kolkata. Fees once submitted will not be refunded.

• The candidates will have to deposit Caution Money (refundable after completion of course) of Rs. 2500/- at the time of admission, through crossed Demand Draft drawn in favour of the "Administrative officer, Regional Labour Institute, Kolkata" payable at Kolkata.

- This provisional admission will be granted based on the information/documents furnished by the Candidates as per their application form and during the admission process. In case of any credentials/information/document/certificate etc. being detected or identified or being noticed at any point as false/fabricated/tampered/misleading, his/her candidature and certificateare liable to be cancelled and the fees paid will not be refunded. Appropriate action in this regard will be initiated by the Director in Charge/Head of Office.
- All the Students are required to bring TWO passport-size photographs and one set of self-attested photocopies of all documents/certificates/testimonials including educational & experience certificates along with originals.
- **During the training programme, more than 80% attendance is desirable.** A minimum of 75% attendance is mandatory to appear for final examinations. Attendance will be counted from the first day of commencement of the course. Special consideration of 5% attendance on Medical Ground will be considered with discretion of Program Coordinator/Director in Charge/Head of Office. Those who do not fulfil the minimum required attendance criteria would not be allowed to appear in final examinations.
- All students are required to adhere to the uniform formal dress code with White Coat/Apron.
- The expenses towards Food/Stay/Travel/Industry Visits/Project Work/Term Work/Examination fees/Lab Reports Books/Stationeries/copies of study materials/handouts/lectures/ notes/Safety Shoes/Safety Helmet and other assignments, etc. as part of the curriculum have to be borne by the candidate himself/herself/sponsoring organization.
- The classes will be held from 09.30 am to 05.00 pm on all working days (Monday to Friday). Students are expected to devote their full time to the course.
- During the tenure of the course, students are required to keep track of the different components of the training programme. The Institute will not be responsible if any deadline is missed by the student.
- Any kind of indiscipline/uncivilized behaviour and un-parliamentary language in the Institute, hostel, and campus will be dealt strictly and disciplinary action will be initiated by the competent authority.
- There shall be a total ban on any act of ragging performed directly or indirectly by any student of the Institute. No student shall commit, abet, propagate, or participate directly or indirectly in ragging in or outside the Institute.
- Every student is required to observe discipline and maintain decorous behaviour both inside and outside the Institute and not to indulge in any activity which will tend to bring down the prestige of the Institute and against the professional ethics of the medical practitioners. Appropriate action will be taken and communicated to the appropriate authority or organization based on the findings of the disciplinary committee, constituted byDirector in Chargefor enquiry in the matter. If a student indulges in malpractice, he/she shall be liable for punitive action as prescribed by the Institute from time to time.
- For any matter related to this training programme, the Decision of the Competent Authority of the DGFASLI or Regional Labour Institute Shillongas applicable/appropriate shall be final.

#### **HOSTEL ACCOMMODATION:**

A limited number of non-family hostel accommodationsmay be available on sharing basis in the Hostel of the Institute at a Central Government-prescribed rate. The canteen facility will be available on pay and use system, if majority of the students agrees to the facility. The programme is non-residential. Staying in the hostel is optional and not compulsory. **Mere application for the course/hostel accommodation does not confirm the allotment of the Hostel**. The allotment of the hostel rooms is subject to availability. The decision of the Director In-charge/Head of Office in this regard shall be final.
