Certificates issued solely by contractors or other agencies shall not be considered valid.** The period spent on higher studies in the field of modern medicine i.e. recognized post graduate medical degree/diploma (MD/MS/DNB/Diploma) or an equivalent recognized medical qualification as per provisions of the NMC Act 2019 and the repealed Indian Medical Council Act 1956 shall be considered as equivalent to general working experience."

Mere application for the training programme does not confirm the allotment of the seat. 
