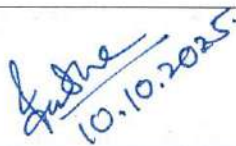

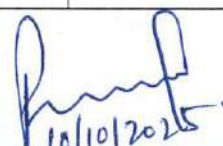

Note:

- Document verification and admission for Rank No. 1 to 30 will be held on 27.10.2025 (from 1000 hrs to 1700 hrs) and for Rank No. 31 to 50 will be held on 28.10.2025 (from 1000 hrs to 1300 hrs). Applicants shall report to the Institute as per their ranks on the respective dates at 1000 hrs.
- Vacant seats if any will be filled from the waiting list applicants (i.e. Rank No. 51 to 66) on 28.10.2025 from 1400 hrs to 1700 hrs. Applicants shall report to the institute on 28.10.2025 at 1400 hrs.
- Those who were eligible as per the 'Eligibility & Non-eligibility List' shall fulfill the requirements mentioned in the remarks column of the said list during the documents verification on schedule dates. Filling which candidates will not be consider for admission and will be treated as non-eligible.
- Applicants shall bring four (04) passport size photographs, all original documents attached with the application form and relieving order from present employer.
- Any discrepancy/short fall / mismatch if found during documents verification, the candidature will be cancelled. No request in this regard will be entertained.
- Fresh sponsorship certificate mentioning all the details as per the prescribed format including Name, Signature and Designation, Contact Details, Seal, Address etc. of the Sponsoring Authority. Signature/Name of "FOR" the competent authority will not be considered.
- The candidates will also be required to pay the Program Fees of Rs 30,000/- (Rs. Thirty Thousand only) through online mode - Bharat Kosh only, after their certificates have been verified and they are admitted to the course. The candidates shall come prepared with online payment facility like internet banking/ debit card/ Credit Card/ UPI. Printout of the receipt generated on Bhart Kosh on successful payment has to be submitted to the Institute on the day of admission.
- The accommodation in RLI Shillong Hostel will be allotted by random mapping through Software on sharing basis only. The Payment of the hostel charges has to be paid in advance at the time of room allotment for the course duration i.e. on 03.11.2025.
- No request for accommodating family members in RLI Shillong hostel will be entertained.

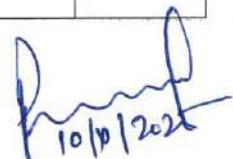
