**Category-wise Vacant Seats for Admission to Advanced Diploma in Industrial Safety (ADIS), Academic Year 2026-27 after completion of the admission process for the merit-list candidates belonging to the jurisdiction States/UTs of Central Labour Institute (CLI), Mumbai**

This notice is applicable only to the waitlisted candidates belonging to the jurisdiction States/UTs of Central Labour Institute (CLI), Mumbai.

It is hereby informed that, after completion of the admission process for the merit-list candidates belonging to the jurisdiction of CLI, Mumbai, certain seats have remained vacant in the Advanced Diploma in Industrial Safety (ADIS), Academic Year 2026-27.

The category-wise vacant seats available for admission from among the waitlisted candidates of CLI Mumbai jurisdiction States/UTs only are as follows:

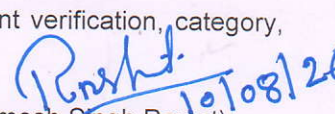
Reservation for Female Candidates, Persons with Disabilities (PwD), Orphan Candidates, Economically Weaker Sections (EWS), Socially and Educationally Backward Classes (SEBC), and Sons/Daughters of Defence Service Personnel shall be provided against the above vacant seats, as per the applicable rules of the Government of Maharashtra. Candidates claiming such reservation shall be required to produce the requisite valid certificates/documents issued by the competent authority at the time of admission/document verification.

The admission against the above vacant seats shall be carried out strictly from among the eligible waitlisted candidates of the respective categories belonging to the jurisdiction of CLI, Mumbai, as per the prescribed admission procedure and merit/waiting list.

All other terms and conditions, instructions, eligibility requirements, original document verification requirements and admission procedure shall remain the same as mentioned in the Admission Notice issued by Central Labour Institute, Mumbai, dated 07.08.2026.

**Note:**

1. This notice is strictly applicable only to waitlisted candidates belonging to the jurisdiction of CLI, Mumbai.
2. Candidates shall be considered for admission subject to fulfillment of all prescribed eligibility conditions and successful verification of the required original documents.
3. Admission shall be granted strictly against the available vacant seats in the respective category and as per the applicable admission rules/procedure.
4. The decision of the Central Labour Institute, Mumbai, regarding eligibility, document verification, category, merit and admission shall be final and binding on all candidates.
