Industrial workers in their day-to-day work are exposed to occupational Airborne contaminants viz., gaseous form (gases and vapours) or as aerosols, which include airborne dusts, sprays, mists, smokes and fumes. Airborne dusts are of particular concern because its exposure are associated with classical widespread occupational lung diseases like Pneumoconiosis, and also systemic intoxications like lead poisoning, etc., The objective of this program is to deliver theoretical and practical aspects on dust exposure at workplaces and its assessment through monitoring techniques.
