These agents may Adversely affect the health of the workmen on repeat & prolonged exposure which can give rise to Physical Hazards exposed on noisy operations are likely to develop Noise Induced Hearing Losses which is one of the notifiable disease under Section 89 of the Factories Act 1948. Similar provisions are laid down for controlling the effects of other Noise and vibration .It is expected from the industrial management to provide adequate arrangements for their evaluation and control. Therefore, Central Labour Institute, DGFASLI, Mumbai is providing online training platform for Intended participants to learn from their own place using mobile phone/laptop/desktop (with webcam, microphone & speaker) in view of COVID 19 pandemic situation/preventive measures.
