The cover should be put in another outer cover and may be dropped in the Tender Box kept at **Regional Labour Institute, Adyar, (Near Madhayakailash), Chennai - 600 113** Both the inner and the outer covers should be super scribed in Bold Capital letters "**QUOTATIONS FOR DISPOSAL OFVEHICLE**"
2. The disposal of VEHICLE shall be strictly on "**AS IS WHERE IS BASIS**" and no guarantee or certificate of its worthiness or quality will be given by this Department.
