Background

In the age of Industrial revolution 4.0, the size and scale of the industries are redefining themselves. The factories are operating on their full potential in every sector employing workers in large numbers. The wide spectrum of processes, operations, materials handling are the part of routine activities on daily basis and hence the industrial workers are surrounded by potential hazards all the time at their workplace where they often carry out various tasks such as work on assembly or production line, assembling items, operating machineries, controlling processes, loading/unloading of raw materials, transportation of goods, materials etc and packaging.

The safety hazards pertaining to the workplace may change depending on the following factors;

- The task being carried out
- The equipments into operation
- The substance/materials being handled.
- The processes into production cycle
- Compliance to SOPs

The aforesaid activities at work place either manually or mechanically may cause accidents (minor or major) and hence compliance to safety protocols, guidelines, prescribed rules and regulations are essential to ensure safe and healthy workplace. It is also important to follow the correct statutory Accident Reporting procedures in the event of an accident occurred within the work premises (factories), which is statutory requirement to avoid non-compliance on the part of employer.

Therefore, Central Labour Institute, DGFASLI Mumbai is providing online training on “**Statutory Provisions on Accident Reporting at Workplaces**” for Intended participants to learn from their own place using mobile phone/laptop/desktop (with webcam, microphone & speaker) in view of COVID-19 pandemic situation/preventive measures.
