Use of Foot & Leg Protectors such as Safety Shoes, gumboot etc. as a Personal Protective Equipment (PPE) has considerably been increased in industries to protect their workers from injuries and accidents as well as to safeguard from various hazards such as compression, fall of object, electrical, chemical, penetration etc. It is very much understood that the degree of protection that these devices can provide greatly depends on the quality of such PPE available along with effective use of selection and maintenance of the same at the place of work. To ascertain quality of Foot & Leg Protectors, they shall be tested as per relevant standard laid down by Bureau of Indian Standards.
