As per the PDCA, the provision of Safe Workplace has to be monitored on a continual basis for which internal Safety Audit is essential, at least once in a year by a team of safety experts becomes essential. This training programme on 'Safety Audit' is designed to equip the delegates to understand the techniques of external as well as internal safety audit to enable them to implement measures for improving the working conditions in the factory/ port/ construction sites and better compliance with legislative requirement.
