#### Background

Wire ropes are widely using in Industries and Ports for lifting and raising in cranes, Material handling and for transmission of mechanical force. Recent accident investigation found that several workplace incidents involving wire rope failures, often resulting in worker fatalities. Because the wire rope break is unpredictable, workers are at risk for crushing and struck-by injuries. Understanding how wire rope is structured, what causes degradation, what to look for when inspecting ropes, and how often to inspect them assists in the prevention of both wire rope failure and worker injuries and fatalities.

Therefore, Regional Labour Institute, Chennai is providing online training platform for Intended participants to learn from their own place using mobile phone/laptop/desktop (with webcam, microphone & speaker) in view of COVID-19 pandemic situation/preventive measures.
