### About DGFASLI

We are the DGFASLI an attached office of the Ministry of Labour & Employment, Government of India and serves as a technical arm to assist the Ministry in formulating national policies on occupational safety and health in factories and docks. It also advises factories on various problems concerning safety, health, efficiency and well - being of the persons at work places.

### Background

Fall of person from height is among the most common case of serious work related injury in an industry, docks and construction work. Use of full body harness / safety belt as a personal protective equipment is considerably been increased to protect worker when they working at height. Full body harness / safety belt reassures the safety when workers works at dangerous height and it will not only reduce the risk of an accident, but it will also allow working with comfort. It is very much understood that the degree of protection that these equipment can provide greatly depends on the quality of full body harness/safety belt available along with selection, effective use and maintenance of the same at the place of work. To ascertain quality of full body harness/safety belt, they shall be tested as per relevant standard laid down by Bureau of Indian Standards.

Therefore, Central Labour Institute, DGFASLI Mumbai is providing online training platform for Intended participants to learn from their own place using mobile phone/laptop/desktop (with webcam, microphone & speaker) in view of COVID-19 pandemic situation/preventive measures.
