Course Objective

The objective of this course is to impart the knowledge and skills to the supervisors working in construction sites so that they can effectively manage the OSH issues at the sites and contribute in prevention of accidents, injuries and occupational diseases.

Eligibility

Supervisors working in construction industry with minimum one year experience are eligible to attend the course. Only 50 candidates will be accepted on 'first come first serve basis' to ensure quality learning.

Pattern of Examination

The candidates have to write pre-test as an assessment before the start of the course. Attendance of minimum 80% will be required for the candidates to appear for the final examination, which will be conducted at the end of the course. The candidate must secure minimum 60% marks to pass and be eligible for the award of the certificate. The successful candidates will be provided with certificate.

About DGFASLI

DGFASLI is an attached office of the Ministry of Labour & Employment, Government of India and serves as a technical arm to assist the Ministry in formulating national policies on occupational safety and health in factories and docks. It also advises factories on various problems concerning safety, health, efficiency and well-being of the persons at workplaces.

Background

The construction sector employs nearly 51 million and contributes approximately 9% of the nation's GDP. This sector employs a large number of unskilled and migrant labour. The sector also contributes to a large number of accidents at workplaces. Therefore, there is an emerging need to manage the safety and health aspects at the construction sites in more effective way. The cost of accidents at construction sites is very high, taking into consideration the suffering caused to injured, kin and kith of the deceased's family and impact on the construction company.

The employees in the supervisory and above capacity, and the individuals after completing the ADIS/PDIS/DIS course conducted by DGFASLI, get appointed as safety Officer in Factories, Dock Works, Construction Sites and other establishments. At present, there is a huge gap in equipping the supervisors on OSH and it is of paramount importance that we train the supervisors adequately on OSH for effectively ensuring safety and health chain in construction sites.

In order to achieve this, it is necessary that the supervisor is trained through a structured program on Occupational Safety and Health (OSH) in construction industry.
