INTRODUCTION

Amendments to the **Factories Act 1948** and enactment of the **Manufacture, Storage and Import of Hazardous Chemicals (MSIHC) Rules** and **State Factories (CIMAH) Rules** have placed specific responsibilities on management for proper handling of Hazards and implementation of statutory provisions. Therefore, it is imperative that all concerned particularly those in the Major Accident Hazards industries should be fully aware of the hazards associated with process/ substances along with the control measures that needs to be adopted.

In the last few decades, large number of Chemical Industries/processes/storage have come up on the Industrial Map of the Nation resulting manifold increase in the use of various Hazardous Substances viz. inflammable, explosive, toxic, corrosive, reactive etc. and some time possess more than one hazardous characteristic. Hazards are increasing in Chemical industries due to complex processes, increasing number of chemicals, plants, equipments and subsequently risk of accidents and health damages from the chemical processes/ storage are also increasing.

In view of the above, ensuring safety has become a challenge for all industries in general and for chemical process industries/storage in particular. Therefore in order to provide comprehensive information on various aspects, the Central Labour Institute, Mumbai is organizing a 03 days' Workshop on “**Major Accident Hazards Control**” from **15th to 17th June, 2022**, enabling industrial management in compliance and creating a safe, healthy and comfortable workplace for better productivity.
