Background

The Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 is a social welfare legislation that provides for the welfare and safety of workers engaged in building and other construction activities. Compliance with the provisions of the Act is essential for the safety and health of workers, as well as for the smooth functioning of construction sites. This training program is designed to impart knowledge and skills to supervisors at construction sites on the compliance requirements under the Act.

Programme Preamble

This program intends to benefit the safety officers / safety professionals / supervisors working at construction sites / construction related works inside factory premises in managing risks at ALARP levels.

- Responsibilities of employers, supervisors, and workers under the Act
