Background

It is often easier to prevent fires starting than to control or extinguish them once they have started. Therefore, there has been increasing emphasis on fire prevention as one of the most cost-effective measures in dealing with the fire problems in industries. Further it is mentioned in the Factories Act 1948 under Section 38 that all practicable measures should be taken in the factories to prevent outbreak of fire and its spread both internally and externally. Adequate facilities and technical abilities of the manpower are key elements for effective prevention of fire hazards.
