INTRODUCTION

Central Labour Institute Mumbai is organising a 03 day’s Training Programme on “Management of Hazardous Substances” from **25th to 27th September, 2023** to enable the Occupier/Manager to discharge duties as per the Factories Act, 1948 and State Factories Rules made there under.

The amendments to **The Factories Act, 1948 amended in 1987** and **enactment of the Manufacture, Storage and Import of Hazardous Chemicals (MSIHC) Rules, 1989** have placed additional responsibilities on the managements for proper management of hazardous substances. Implementation of statutory provisions on the part of the Management to ensure proper use, handling, storage, import and disposal of hazardous substances/chemicals and to arrange for necessary supervision during hazardous processes is very important. It is, therefore, imperative that all concerned particularly those in the hazardous process industries should be fully aware of the hazards associated with the use of hazardous substances and control measures that need to be adopted.

In order to provide comprehensive information on various aspects relating to the use, handling, storage, transportation, disposal of hazardous Substances, their impact on health & safety, the Central Labour Institute, Mumbai is organising a 03 day’s training programme on **“Management of Hazardous Substances” from 25th to 27th September, 2023.**
