**ONE MONTH CERTIFICATE COURSE IN SAFETY & HEALTH FOR SUPERVISORS TO BE EMPLOYED IN
HAZARDOUS PROCESS INDUSTRIES U/S 41C(b) OF THE FACTORIES ACT, 1948**

Date: 28.11.2023 to 27.12.2023

THE COURSE PERSPECTIVE:

Section 41C(b) of the Factories Act 1948, lays specific responsibilities on the occupier in relation to industries involving hazardous processes and further states that every occupier of a factory involving a hazardous process shall appoint persons who possess qualifications & experience in supervising hazardous processes in the factory.

Realizing the needs of supervisory personnel as above, one month certificate course is being conducted at **Regional Labour Institute, Faridabad**, to provide an opportunity to gain insight of safe systems & procedures.

METHODOLOGY & COURSE CONTENTS:

Training techniques to be used during the course will be lectures, discussions, case studies, laboratory exercises, audio-visual aid & factory visits. The participants will be required to visit a factory as a part of practical exposure and to prepare a Project Report on Factory Visit as a requirement under the syllabus. Following topics will be covered during the course.

- Statutory Provisions
- Basic Principles of Accident Prevention
- Techniques of Identification of Hazards
- Prevention & Control Techniques
- Chemical Hazards & Specific Control Measures
- Fire & Explosion Hazards
- Health Hazards due to chemical exposures
- Chemical Emergency Preparedness
- Counselling & motivating for safety & health
- Others (Safety Audit, OSHAS, Environmental Management Systems, Communication, training Cycle, Behavioral & Physiological aspects, total safety Culture, resilience Engineering)

At the end of the course, the participants will be required to undergo an examination conducted by DGFASLI, Mumbai comprising of Laboratory work (Safety, Hygiene and Industrial Medicine), Oral examination based on project/laboratory work and written examination. Certificates will be awarded to the successful candidates.

COURSE DURATION:

The course will be conducted **from 28th November, 2023 to 27th December, 2023**. Full time (minimum 6 contact hours per day) – 4 weeks (Two weeks classroom teaching followed by one-week project work and on completion of which a further one-week classroom teaching – 85 classroom sessions). The teaching hours at the Institute will be from **10 a.m. to 5 p.m.**

FACULTIES:

The faculties will be the officers from various disciplines of the Institute, specialists from Industries, different Institutions & Government departments.

QUALIFICATIONS FOR ADMISSION:

- (i) A degree in chemistry or a diploma (three years full time) in any branch of engineering or technology or equivalent with not less than 5 years' experience.
- OR**
- (ii) Master's degree in chemistry or a degree in any branch of engineering or technology or equivalent with not less than 2 years' experience.

NOTE: The experience stipulated above shall be in process operations and maintenance, in any hazardous process industry.

ATTENDANCE:

Minimum 80% attendance shall be required for appearing in the final examination. The minimum requirement is mandatory even if a candidate is declared sick on medical ground.

FEE & OTHER EXPENSES:

- (1) Institution Fee: **Rs. 7,500/- per participants** - for the entire course. The fee is payable immediately on receipt of conformation of seat in the course & before joining the course online payment through www.bharatkosh.gov.in. **Fee once paid is not refundable. It is advised to ensure confirmation of your selection in the course from the course coordinator, before making online payment.**
- (2) The expenses for the visit to the factories will be borne by the candidate or respective sponsoring organizations.
- (3) Rs. 2500/- per candidate in cash is also payable as caution deposit (Refundable) for availing library & Laboratory facility

NOMINATIONS:

Intended candidates can express their interest by sending the duly filled application form in prescribed proforma along with necessary attachments through Speed post to "The Head of Office, **Regional Labour Institute, Faridabad, Sector-47, Haryana – 121 010**. After confirmation by the course coordinator only, candidates shall deposit institution fee @ Rs 7,500/- (Rs. Seven thousand five hundred only) per candidate through Bharatkosh portal (<https://bharatkosh.gov.in>). Fees once submitted will not be refunded/ adjusted.

Application should be accompanied with self-attested copies of certificates & mark sheets of qualifying examinations and experience certificates from employers for the qualifying period and should be duly forwarded by the sponsoring organization (if any). **The above testimonials in original will have to be produced by the candidates at the time of registration to be held on 28.11.2022 at 10.00 AM at the Institute, failing which admission shall not be granted. There are limited numbers of seats which will be allotted to eligible candidates on first come first serve basis.** The decision of the institute will be final, in respect of the selection of the candidates.

Staying in the hostel is optional and not compulsory. Mere application for the hostel accommodation does not confirm the allotment of the Hostel. The allotment of the hostel rooms is subject to availability and will be allotted on **first come first serve basis**.
